The above named stud will be bred to the above named bitch with the following terms to apply:

- 1) The stud fee of \$2500.00CAD or a show quality - pick puppy as agreed upon at the signing of this contract. If no suitable show quality puppy is selected at 8weeks then the stud fee will be accepted on or before the date the puppies turn 9weeks of age.
- 2) The stud fee is due when the litter is whelped, and three live puppies are confirmed. Three live puppies constitutes a complete stud service by the above mentioned stud dog. All stud fees are non-refundable. No registration papers will be signed without payment in full and/or all other related breeding expenses as detailed in this contract. All veterinarian, collection, shipping/transportation expenses are the responsibility of the bitch owner.
- 3) Three live puppies at 72 hours shall constitute a litter and fulfill the stud owner's portion of this contract. If less than three puppies are produced by this mating a return stud service on the next heat cycle of the same bitch or an approved alternate bitch will be given with all other terms of this agreement to apply to the return breeding. In the event said bitch should die, be unable to conceive or carry a litter after the second attempt, the owner of the stud dog is under no further obligations under the terms of this contract and no monies will be returned.
- 4) No puppies resulting from this breeding shall be sold to any pet shops, puppy farms or with unrestricted breeding rights to any non-show or performance homes. Pet

puppies must be sold as non-breeding on spay/neuter contracts with the non-breeding space on the registration papers filled in/checked off. In addition, NO puppies are to be advertised for sale on Puppy Finder or any type of puppy brokering sites.

- 5) All rear dewclaws will be removed, front dewclaws at the owners discretion, all tails will be docked.
- 6) Stud owner to be notified within 48 hours of whelping and or due date if no puppies are whelped. Stud owner would like to be notified if an ultrasound or X-ray is used for assessment throughout the pregnancy.
- 7) Bitch owner will notify the stud dog owner of any titled offspring from this breeding.
- 8) Bitch owner to have all puppies' eyes examined by a canine ophthalmologist and supply stud dog owner with results.
- 9) Bitch owner agrees to take back and re-home (should the need ever arise) any puppies resulting from this breeding.
